

Regulation Order n. ° 385/2016 of September 14th

Introduces the new fees to be charged for the services provided at *Arquivo Regional e Biblioteca Pública da Madeira*.

Article 1 - 2nd Paragraph - All certificated documents from the Civil Registry, Notaries, Courts and Official Finance's Services, issued/certified by ABM, shall be applied accordingly; procedures, regulations and new fees to be charged for such entities as follows:

Civil Registration and Nationality Fees – Decree-Law No. 322-A/2001 of December 14 th with the corresponding amendments. Fees for Birth/Marriage/Death Records Certificates - issued by the ABM's Regulation Fees of Registries and Notaries, according to Article 2, No. 3 of above-mentioned Regulation Order.
